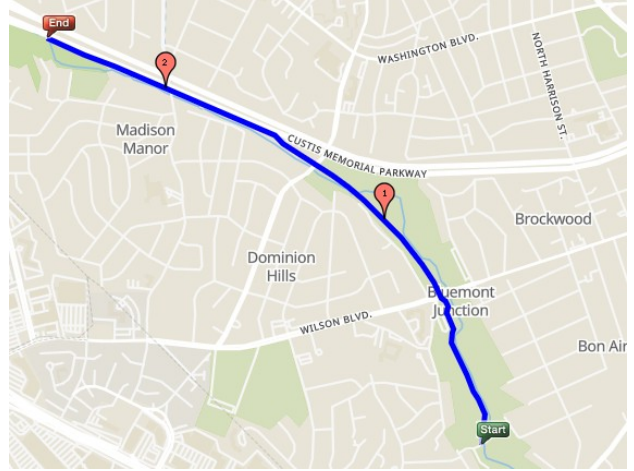

- **Directions:** From Route 50, turn north at Manchester Street
Continue to the park driveway on the right. Free parking
- **Race-day:** On-site registration is open
7:15 AM to 8:45 AM – **Race-day registration is OK**
- **Course:** Paved park path, one gradual hill
No road crossings, OK for walkers and wheelchairs
